

**Abstract of Assessment**

**THE ASSESSOR DOES NOT SET ANY TAX LEVY**

County tax is levied by the Board of County Commissioners.

City and town tax is levied by city and town officials.

Special districts tax is levied by their boards of directors.

School tax is levied by their school boards.

After the levies are certified to the County Assessor by the County Commissioners, it is then the duty of the Assessor to extend the taxes on property and create the tax warrant roll.

Utilities are assessed by the Colorado Division of Property Taxation.

ALL PROPERTY, EXCEPT THAT SPECIFICALLY EXEMPT BY LAW, is subject to taxation and it is the duty of the owner, by law, to see that it is listed with the Assessor.

Actual value is based on a June 30, 2014 level of value. Actual Value times the Assessment Rate equals the Assessed Value.

The 2015 Residential assessment rate is 7.96% of Actual Value. The assessment rate for Non-residential property is 29%. Primary Oil and Gas production is assessed at 87.5% and Secondary production at 75%.

The Assessor's Office is ready at all times to give courteous answers to inquiries relating to valuation, assessment, and taxation of any property.

**IMPORTANT INFORMATION**

- 2015 TAXES ARE DUE January 1, 2016. Taxes may be paid in two equal payments. To avoid interest, the first half must be paid by February 28th, the last half must be paid by June 15th. No penalty if paid in full by April 30th.
- Property will be advertised for sale for delinquent taxes in October. The sale will be held during the month of November. Personal Property and Mobile Home taxes are advertised in September.
- Delinquent taxes on Mobile Homes will be sold at Tax Lien Sale, and title to it may be issued one year from date of sale if not redeemed.
- When property is sold at Tax Lien Sale, the amount for which it is sold draws interest at the rate of 9% above the Federal Reserve Discount rate as of September 1st of that year and stays the same rate for the term of the certificate.
- Property may be redeemed at any time within three years from the date of sale. After three years a tax deed may be legally issued.
- Please bring your tax notices or payment coupons when paying your taxes. They keep us from missing property. If your tax notice does not cover all of your properties, notify the County Treasurer. It may be assessed under some other name. Check your receipts.
- If you have any questions concerning payment of your taxes, please contact our office.
